An average of 2,204 families were served each week at S Nelson St or at one of 18 other distributions sites around the County for a total of 116,590 visits to receive their weekly food supplies. During a visit a family will be able to select a variety of healthy, nutritious food including milk, eggs, fresh fruit & vegetables, pasta, sauces, cereals breads, pastries and a number of miscellaneous items. In addition, AFAC provides backpacks of food to students in the Arlington Public Schools who do not have sufficient foods supplies over weekends and long holidays. AFAC received 1,304,503 lbs through food donations from individuals,
